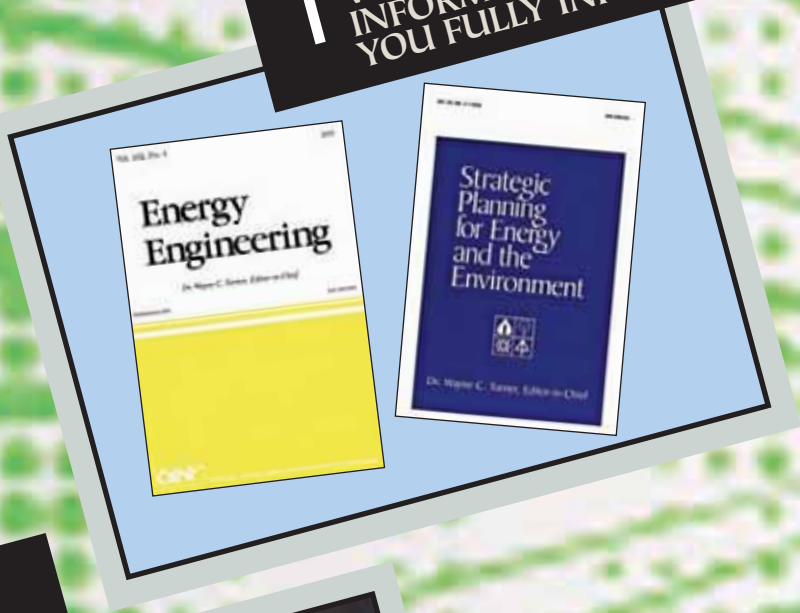

IN TRAINING PROGRAMS (EMIT, CIAIT, CGDIT, CMVPIT) are designed for talented professionals who pass the exams but do not yet have the necessary credentials. If these individuals gain the necessary credentials within three years of receiving the "In Training" designation, documentation may be submitted to AEE and certification will be awarded without additional testing or fees.

Certified Energy Manager® Program (CEM®) ENERGY MANAGER IN TRAINING (EMIT®)

Since 1981, AEE's flagship certification program has emphasized the technical aspects of what energy managers in government and the private sector need to know. The CEM® represents a "Who's Who" in energy management. More than 8,000 individuals hold the status of Certified Energy Manager®. Certified Building Energy Professional (BEP)

The BEP program awards special recognition to those business/marketing and energy professionals who have demonstrated a high level of competence and ethical fitness for business/marketing and energy management related disciplines, as well as laws governing and affecting energy professionals.

Certified Building Commissioning Professional (CBCP®)

The CBCP® program was developed with the dual purpose of recognizing the most highly qualified professionals in this most rapidly expanding area within the industry, while raising overall professional standards in the building commissioning field.

Certified Carbon Reduction Manager (CRM)

The CRM program is designed to recognize those professionals who have distinguished themselves as leaders in the growing field of carbon reduction. The designation CRM identifies individuals who have demonstrated high levels of technical expertise in energy management and environmental practices.

Certified Energy Auditor (CEA) CERTIFIED ENERGY AUDITOR IN TRAINING (CEAIT)

This certification was developed and added to the impressive portfolio of certifications offered by the AEE. Rising energy costs and inefficiency in plants and buildings is continually driving the need for trained and experienced energy auditors. CEA certification identifies professionals having the required knowledge and experience needed to succeed in the field of energy auditing.

Certified Energy Procurement Professional (CEP®)

AEE's Certified Energy Procurement Professional (CEP) program is designed to award special recognition to professionals who have demonstrated a high level of knowledge, expertise, competence, and ethical fitness covering the full spectrum of activities related to the purchase, sale, and marketing of electricity and natural gas.

Certified Lighting Efficiency Professional (CLEP)

The Certified Lighting Efficiency Professional (CLEP) program is also recognized as meeting the requirements of the EPA GreenSource Management Company Alliance.

Certified Green Building Professional (CGBP)

The GBETM program awards special recognition to those green building, design, and construction professionals who have demonstrated competence and ethical fitness for their disciplines, as well as laws governing their professional practices.

Certified Power Quality Professional (CPQP)

AEE's CPQP® program develops a strong relationship between the power source and the user, ensuring a high level of power quality and reliability.

Certified Indoor Air Quality Professional (CIAQP)

The CIAQP™ program identifies and certifies the needs of businesses to identify and train their practitioners who are equipped to handle "sick buildings," including those managers who are responsible for ensuring indoor air quality while maintaining comfort and productivity.

CAREER CENTER.

In order to take a more active role in providing members with increased job opportunities, the Association has established an online Career Center (www.aeecenter.org). Unemployed AEE members are excused from membership dues while between jobs.

AWARDS.

AEE gives special recognition to individuals and corporations, agencies, or organizations that have demonstrated notable contributions to the profession and exceptional service to the Association. This recognition is awarded on the local, regional, national, and international levels. Awards are given in these categories: Energy Engineer of the Year, Corporate Energy Management, Energy Professional Development, Energy Manager of the Year, Energy Project of the Year—National, Energy Project of the Year—International, Renewable Energy

Project of the Year, Renewable Energy Innovator of the Year, and Young Energy Professional of the Year. In addition, two special awards may be presented: Energy Executive of the Year and Leadership in Federal Energy Management.

HALL OF FAME.

The Energy Managers Hall of Fame recognizes individuals for their lifetime achievements in promoting the practices and principles of energy management. Those elected to the Hall of Fame are inducted at the World Energy Engineering Congress.

SCHOLARSHIP AWARDS.

The Foundation of the Association of Energy Engineers Scholarship program was established to encourage qualified practitioners in energy engineering and energy management by awarding scholarships to further education in the field. To date the Foundation has awarded over \$520,000 in funds for use by outstanding students dedicated to energy engineering.

Energy Professional (CLEP)

Energy Professional (CLEP) is designed to recognize professionals in the field of lighting efficiency. This program meets the certification requirements of the International Green Building Council's (IGBC) 'Green Lights' Lighting Program.

Green Building Engineer (GBE™)

The Green Building Engineer (GBE™) award grants special recognition to those professionals in the field of construction engineering who have demonstrated a high level of competence in green building related disciplines and affecting green building.

Professional (CPQ®)

The Professional (CPQ®) certification demonstrates the interactions between electrical and sensitive loads in the field of power quality.

Indoor Air Quality Professional (CIAQP™)

The Indoor Air Quality Professional (CIAQP™) is designed to meet the growing demand for qualified indoor air quality professionals to solve problems created by mold, as well as facility professionals responsible for operating healthy buildings and reducing energy costs.

Professional (CGD®)

The Professional (CGD®) certification is designed to recognize professionals with high levels of experience, competence,

and ethical fitness in applying the principles and practices of geothermal heat pump design and related disciplines. CGD® certification is granted by AEE and sponsored by the Geothermal Heat Pump Consortium® (GHPC). Associated training programs are presented by the International Ground Source Heat Pump Association (IGSHPA).

Certified Measurement & Verification Professional (CMVP®)

CERTIFIED MEASUREMENT & VERIFICATION PROFESSIONAL IN TRAINING (CMVPT)

The CMVP® program was established by AEE in cooperation with the International Performance Measurement & Verification Protocol (IPMVP), with the dual purpose of recognizing the most qualified professionals in this growing area of the energy industry, and raising the overall professional standards within the measurement and verification field.

Certified Sustainable Development Professional (CSDP)

The Certified Sustainable Development Professional (CSDP) program is designed to provide recognition for professionals who have distinguished themselves as leaders in the sustainable development field. The designation CSDP identifies individuals who have demonstrated high levels of technical expertise in energy management and environmental practices.

Distributed Generation Certified Professional (DGCP®)

AEE's DGCP® program identifies individuals who have demonstrated high levels of expertise, competence, proficiency, and ethical fitness, bringing to their professional activities the full scope of knowledge essential to the effective

development and management of today's distributed generation projects.

Certified Renewable Energy Professional (REP)

The REP certification is designed to recognize the expertise and experience of professionals involved in the specification and application of renewable and alternative energy technologies, assessment of renewable energy projects, and development of achievable low-carbon and sustainability goals for organizations.

Certified Existing Building Commissioning Professional (EBCP)

AEE's EBCP certification provides recognition for qualified professionals with expertise in the area of retrofitting existing buildings into more sustainable, efficient facilities while meeting existing building commissioning criteria.

Certified Building Energy Simulation Analyst (BESA)

AEE's BESA certification is designed to recognize individuals with special expertise and experience in the area of utilizing building energy simulation software to assess a facility's energy performance.

Certified Residential Energy Auditor (REA)

Rising energy costs and inefficiencies in homes and residential structures are increasingly driving the need for a qualified residential energy auditors. In response to this demand, AEE now offers the REA certification program, which recognizes professionals with energy auditing expertise and experience specific to assessing residential energy use.

Association members can participate in a vast array of Chapter, Division, and Council activities.

CHAPTERS.

The Association of Energy Engineers chapter network includes 71 chapters, comprising 46 in the United States and 25 international chapters. Members have the opportunity to meet with professionals in their area, hear guest experts speak on issues of regional importance, participate in plant tours and other chapter functions, including newsletters.

COUNCILS.

Councils provide a forum for the exchange of information in specialized areas of member interests.

Energy Management Professionals Council (EMPC).

Its goals are to provide representation of women in industry-related policy issues, such as the National Energy Policy, addressing the high cost of energy, our present and future sources of energy, and the impact of energy on the environment; to secure a future in energy-related technical fields for women by supporting training, education, and mentoring of young girls and women; and to contribute to the advancement of women in leadership positions throughout the industry.
